Entry Requirements

ALL applicants must submit a complete application which includes 3 slides or photos of artwork to be exhibited, a brief biography of the artist and a description of their artwork. **Artwork must be original and exemplify characteristics of fine art or fine crafts.** All applications must include a separate \$10.00 processing fee. The processing fee is non-refundable and must be made out to Taste of Hudson.

Jury Process

A panel of experienced artisans reviews ALL applicants by examining 3 submitted photos or slides of the artist's work. The artist biography and descriptions of submitted work assists in the jury process. Judges' decisions are final.

Booth Fees

10 x 10 booth space: \$125.00

10 x 10 booth space & tent rental: \$225.00

*WHITE TENTS ONLY, IF USING YOUR OWN!

Volunteers will be available to help with unloading. All exhibitor vehicles must be unloaded at designated area and removed prior to start of the show each day.

No refunds on cancellations after August 1, 2010.
